MINUTES OF THE 57TH ANNUAL GENERAL MEETING

The minutes of the 57th Annual General Meeting held on 10 December 2020 having been circulated within the prescribed period, were taken as read.

<u>MATTERS ARISING</u> – the draft new Constitution which was tabled and approved at the 2020 Annual General Meeting were not approved by the Registrar of Societies, as some clauses did not comply with the Societies Act. A new Constitution following the guidelines have been tabled for approval at this General Meeting.

PRESIDENT'S REPORT AND AUDITED ACCOUNTS FOR 2020

The President's Report and Audited Accounts for the year ended 31 December 2020 having been duly circulated within the prescribed period, were taken as read.

The Committee's Report was unanimously approved on the proposal of Mdm K. Tan, seconded by Mrs P. Nadkarni.

The Secretary reported the Auditor's recommendations to minimize cash and cheque payments, but to use electronic transfer payments; and a more systematic way of collecting subscriptions.

There being no further questions on the Audited Accounts, Mdm A.M. Narcis proposed that the Audited Accounts for 2020 be adopted. This was seconded by Mdm B. Tan unanimously carried.

MALAYSIAN CONTRACT BRIDGE ASSOCIATION CHAIRMAN'S REPORT 2021

Bridgewise, 2021 was an uneventful year. Due to the Movement Control Orders ("MCOs") and travel restrictions put in place to curb the spread of COVID 19, practically all local, regional and international bridge events were cancelled. For the greater part of the year, no inperson bridge sessions were held. Subscriptions for 2021 were waived, thus membership number is taken to be static from 2020, at 58 members.

Fortunately for the bridge addicts, the game could still be played through on-line platforms, such as Bridge Base Online (BBO) and the newly launched RealBridge. The advantage of these on-line platforms is that bridge can be played anytime, with or without a partner.

2021, sadly, also marked the passing of Toh Puan Norella Talib on 15 October 2021. Our MCBA President for more than 40 years, Toh Puan was ever present in our local bridge scene and a good friend to many. We will all miss her dearly, may she Rest in Peace.

When it seemed that the year would pass without in-person bridge sessions, the Malaysian Government suddenly announced a relaxation of the MCO, allowing indoor activities albeit with strict Standard Operating Procedures. This enabled a few clubs to resume bridge activities, notably the Ladies Bridge Club Tuesday, Royal Selangor Club Thursday and Lake Club Saturday sessions. The turnouts were initially small but gradually grew larger. However, it will take time for the numbers to return to the pre-COVID era.

The relaxation of the MCO also enabled MCBA to hold its long delayed AGM on 16 December 2021. We welcome our new President Puan Sri Ling Lee Hung, Secretary Mr David Law, Treasurer Ms Hildah Lee and committee members Mr Mahinder Randhawa, Ms Ann Marie Narcis and Ms Tan Kim Choo to the MCBA Committee.

In conclusion, I would like to thank our Honorary Auditor for 2021 Encik Mohd Ramzi Mohd Sharif, as well as all members who have supported and participated in our MCBA bridge activities.
